Born in Tokushima-ken, March 1, 1883.

Graduated from Middle School Department, Kwansai Gakuin, Kobe, 1901. Studied in Junior Department of same, 1901-02.

Entered the University of Michigan, U.S.A., 1902.

Graduated from same, 1906, receiving B.A. in history and economics. First honors in the University Oratorical contest, 1906. First honors in the Northern Oratorical League contest, 1906. Studied as special student in law, same institution, 1906-07.

Chautauqua and Lyceum Lecturer, 1908-11. Delegate of the Great Lakes International Arbitration Society to the International Peace Congress, Edinburgh, 1911 and delegate, First International Races Congress,

London, 1911.

Lecturer, The American Peace Society, 1908-11.

Returned to Japan and travelled in China, 1911-12.

General-Secretary, The Japanese Association of America, 1912-14.

Japanese Corresponding Member, American National Education Association, 191.

Lecturer, Occidental College, Los Angeles, 1916-23.

Lecturer, University of Southern California, 1917-23.

Secretary to the Senior Government Delegate to the First International Labor Conference, Washington, 1919.

Secretary, The Japanese Parliamentary Delegation, (summer 1921).

Attended the Institute of Politics, William College, 1921.

Studied International Law and Diplomacy, Summer School, Northwestern University, 1922.

Auditor, Sorbonne University, Paris, 1922.

Delegate to the General Assembly and Council of the International Federation of the League of Nations Associations, 1922-23.

Returned to Japan, 1923 (earthquake) and travelled in China.

Commissioner in charge of the Foreign Section, The League of Na-

tions Association of Japan, 1924-30.

Appointed expert of the Foreign Office, 1930.

Attached to the Japanese Embassy in China, stationed in Shanghai.

Decorated by H. I. J. M. with Sixth Order of Rising Sun, 1936

Travelled in Australia and New Zealand, returning to the post with the Japanese Embassy in China, May, 1937.

Ordered to go to Honkong July 1, 1938.

Travelled extensively in Manchukuo and China, 1938.
