RICHARD G. MITCHELL, Vice President, Genge Consultants of West Los Angeles, until recently the successful administrator of the Community Redevelopment Agency of Los Angeles.

Prio to joining Genge Consultants Mr. Mitchell served 8 years as Administrator of the Community Redevelopment Agency of Los Angeles, responsible for all urban renewal programs undertaken by the City. During this time he directed operations in 9 community-development project areas, 7 of which became operational while Administrator.

For 3 years Mr. Mitchell was Regional Director of Urban Renewal & Assistant Regional Administrator for Renewal Assistance for the U. S. Department of Housing and Urban Development at the Regional Headquarters Office in San Francisco, supervising Federal Government's urban renewal, housing rehabilitation, and neighborhood improvement operations in the 11 western states and Guam. He assisted nearly 200 city governments and local public agencies in designing urban-improvement programs to meet their needs; and elicited the cooperation of local officials and citizens in the advancement of urban-improvement activities.

Mr. Mitchell's outstanding contributions to government were recognized when he was honored with the prestigious Clarence A. Dukstra Award from the American Society of Public Administrators in 1970.

He is in great demand as both an author and speaker.

Hats off to OZ THORESON and the AMERICAN RED CROSS for their great help in the east and middle west during the tragic winter storms! A bulletin received from the Washington Headquarters of ARC shows the following: at the peak of the storm 40 shelters in the Buffalo area with 10 still open, feeding over 20,000 persons daily who were unable to reach their homes (both Red Cross and Salvation Army mobile feeding vehicles were rescued from snow drifts by New York State National Guard units so they could move through stricken areas feeding victims and emergency workers); in Cincinnati Red Cross

workers have delivered 3,000 gallons of heating oil on a case work basis; in the Cleveland area are delivering food and prescriptions to elderly persons; in Ohio - Red Cross emergency staff is meeting to lay contingency plans for sheltering an estimated 3 million residents in 1,000 locations should fuel shortage or spring flooding make this move necessary. This tells us all that it is wonderful that we have a volunteer organization in our country, chartered by Congress, to move at once into any disaster area in the United States to take care of the needs of our citizens.
