"What Kiwanis Means to Me"

Below are some of the articles submitted in response to the Kiwanis Education Committee's request for letters.

Dear Brother Carroll:

The following is "What Kiwanis Means to Me."

The Kiwanian recognizes that the fundamental reason why he works is to earn a living. "Work or want" is a fact that faces every family man. He recognizes that every job, whether it is teaching or farming, car-selling or druggist, printer or manager, if properly handled is respected and necessary for our total community. "Men successful" also remember that a good business man must be successful in a religious belief. Men who join the Kiwanis Club should be men who are successful as individuals in the areas of initiative, contribution, service, to the Church and God. A man who claims the "K" and can claim success in each of these areas is considered a "good Kiwanian." All jobs have their place and make for common happiness if God has a partnership. **Kiwanis helps men realize** this relationship through its program and leadership.

Something of a curse falls upon a local community when men isolate themselves from one another and fail to acknowledge the numerous ties that bind men together. Pick any community without a service and religious organization and you will see human and community disintegration, discouragement and atrophy. **Kiwanis is a service organization which knits men together** around common working objectives — in service to individuals, to the community and to God.

In Kiwanis the number one objective is to "Enhance the spiritual life of our people, giving active support to churches" and to "Give primacy to the human and spiritual rather than to the material values of life." The final loyalty in life is not to men, nor to a city, nor to any government, but to God. **Kiwanis is a**

AMENDMENT TO BYLAWS San Diego Kiwanis Club Foundation, Inc. ARTICLE VI Distribution of Assets Upon Dissolution

Section 1. Upon dissolution of this foundation, the entire assets thereof shall be distributed to charitable institutions, for charitable purposes, as directed by the Trustees. No part of the assets shall at any time inure to the benefit of any member.

Kiwanis International Resolutions Adopted at the Convention in Cleveland

(Continued from last Tidings)

7. Civil Defense

WHEREAS, being acutely aware that the advent of the atomic age has created unprecedented and awesome possibilities of total warfare; and

WHEREAS, the objective of total warfare is the devastation of the morale of the civilian population and their will to survive as a nation; and

WHEREAS, no nation, however strong its military forces, can survive under conditions of total war without a well-organized and well-informed civilian population:

NOW THEREFORE BE IT RESOLVED, that Kiwanis International urge the governments of our two countries to remove all restrictions, not necessary for security, on information vital for the development of a well-organized civil defense, and that agencies be activated to disseminate this information and instruction to the civilian population; and

BE IT FURTHER RESOLVED, that Kiwanis International, through its member clubs, assist in the task of educating the people of the United States and Canada on the necessity of a functioning Civil Defense being available in all communities for all emergencies.
