NOW THEREFORE BE IT RESOLVED, that Kiwanis International, through its clubs, support:

1. Programs for better understanding of mental illnesses and diseases.
2. Cooperation with all public, private and religious groups concerned with this problem.
3. Study, research and therapy in this field.
4. Training and education of personnel for this work.
5. Legislation on behalf of the mentally ill.
6. The rehabilitation and adjustment of mental patients following discharge from medical care or institutions.
