## THE PROGRAM

DR. ROBERT A MOORE attended the University of Illinois for his pre-medical and medical education after serving in the Army during World War II.

He served his Internship and Residency at the University of Michigan Medical Center, continued on at the University of Michigan Medical School as a Student Health Service Psychiatrist, then Assistant Director of the Veterans' Readjustment Center, then Chief of Adult Services at N.P.I., then Clinical Director of Training and Research at Ypsilanti State Hospital - an affiliate of N.P.I. Dr. Moore organized and directed the Department of Psychiatry at Swedish-American Hospital in Rockford, Illinois from 1965 to 1968. In 1968 he became the Medical Director of Mesa Vista Hospital in San Diego and, subsequently, Vice President of its parent organization, the Vista Hill Foundation. From 1972 to 1976, Dr. Moore was also Director of Mental Health Services for Imperial County, operated by the Foundation on contract. Since his Residency, he has conducted a part time office practice with an analytical orientation.

Dr. Moore served on the faculties of the University of Michigan and University of Illinois, and is currently Clinical Professor at the University of California, San Diego.

He has authored over 65 professional publications and served on the Alcohol Research Review Committee of N.I.A.A.A.. He is a Fellow of the American College of Psychiatrists and the A.P.A..

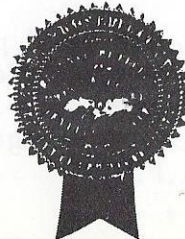
