Judge Lucas, as chairman of the Johannesburg, So. Africa bar council, helped found the General Council of the Bar of South Africa, and became its first chairman. After retiring from the Supreme court of South Africa in 1951, Judge Lucas was named justice of appeal for the High Commission territories, a post he still holds. As leader of the Transvaal provincial council, Judge Lucas drafted and put into effect bills providing for taxation of land values, as well as legislation providing for free education and equal rights for women. He will speak to Kiwanians on "South Africa's Color Bar—Asset or Liability?"
