## Mailing for Christmas

Continued from last week

### HOW TO ADDRESS PARCELS

Addresses must be legible, in typewriting or ink. Copies of sales slips of retail stores should not be used as address labels. A slip containing the complete address of addressee and sender and a list of the contents should be enclosed in the parcel to permit identification in the event the address on the outside becomes defaced or the boxes become broken and the contents scattered.

Parcels addressed to overseas Army personnel should show the grade or rank, full name, Army serial number, service organization and unit, and the APO number in care of the postmaster at the port of embarkation through which the mail is routed. For example:

Pvt. John K. Doe, ASN 32185691  
Company F, 999th Infantry  
APO 000, c/o Postmaster  
New York, N. Y.

### POSTAGE

Postage must be fully prepaid. The rate on parcels of the fourth-class (that is, parcels exceeding 8 ounces) is the zone rate applicable from the post office where mailed to the postmaster at the port of embarkation through which the mail is routed. The third-class rate of 1½ cents for each 2 ounces or fraction thereof applies to packages not exceeding 8 ounces. Parcels containing only books conforming to certain requirements are acceptable at a special rate of postage. Stickers or labels resembling postage stamps are not permissible on the outside of parcels. Inscriptions such as "Merry Christmas," "Please do not open until Christmas," "Happy New Year," "With Best Wishes," and the like may be placed on the covering of the parcel in such manner as not to interfere with the address, or on a card enclosed in the parcel. Books may bear simple dedicatory inscriptions not of the nature of personal correspondence.

### USE OF MONEY ORDERS

Use of postal money orders are recommended for those desiring to transmit gifts of money outside the continental limits of the United States. Domestic and postal money orders may be cashed at APO's wherever they are located, and are paid in local foreign currency at the rate of exchange in effect on the date of the presentation of the orders.

### PROHIBITED ARTICLES

Perishables, intoxicants, inflammable materials (including matches of all kinds and lighter fluids), and poisons are unmailable. The mailing of fragile articles is discouraged.

### CHANGE OF ADDRESS

Christmas parcels for Army personnel enroute overseas shortly



before or subsequent to October 15, 1945, will be accepted after October 15, up to and including December 10, 1945, upon presentation by the sender of a change of address notification (W.D., A. G. O. Form No. 204, or equivalent notice) from the addressee, received subsequent to September 30, 1945. The parcels, however, must come within the prescribed limits of weight and size and be endorsed "Christmas Parcel." Only one such parcel will be accepted from any one person to any one individual having an overseas APO address. The use of the change of address notification as a basis for mailing a parcel to Army personnel under such circumstances is not limited to the addressee of the notice. Parcels mailed to personnel at posts, camps, and stations within the United States will be given directory service and forwarded to overseas stations if the addressees are transferred abroad prior to delivery.

#### COOPERATION OF PUBLIC

The Christmas mail problem will be complicated this year by the fact that thousands of the overseas personnel will be moving from one organization to another under the redeployment procedure. This will cause extensive directory service and forwarding of parcels. The Army Postal Service will exert every effort to minimize resulting delays in delivery. Senders can assist materially in this connection. First, they can exercise care to address parcels accurately and completely to the latest address furnished by the addressee. Second, if they have reason to believe the addressee is to have a change of assignment before delivery of the parcels may be expected, they can defer the mailings until the new address is known, even though this might make it necessary to have the parcels mailed under the "request" procedure after the Christmas mailing period. Third, they can ascertain through correspondence in advance what items the addressee would like to have and limit their mailings to such items.
